Hospice biography team

Mike Merrick will be speaking about the biography service offered by the Taranaki Hospice.

This is a free service provided by volunteers to help hospice patients to record their life memories.



Last Meeting – Tuesday 3 May 2011

At the May branch meeting, Mike Merrick gave an interesting talk about his experiences in researching the War Service Files of a number of his family members. When he read these files initially, he had found them confusing and frustrating because they were written in military jargon, had many puzzling abbreviations and were often not in chronological order.

In desperation, he googled **army files** and fortuitously came across the website www.decode.co.nz run by a former freelance journalist and research assistant at the Waiouru Amy Museum; Briar Corson. She provides a service specialising in the interpretation of army files and the presentation of these in a form which can be easily read. The service normally takes six to eight weeks.

The report Mike received back was typed so that the information was legible, abbreviations were explained and events had been put in chronological order. Mike gave an example of how helpful this was. He had been puzzled by a record which had said 'Marched into Sling'. Briar Corson's report explained that 'Sling' was a Camp on the Salisbury Plains in the UK where further and very exhaustive training was given soldiers (many from Kiwi units) during the War.

The report also contained a section outlining the daily life of the common soldier and another with maps of battles his relatives had been involved in. A list of websites and books was provided for further research.

A pleasing feature was that Briar Corson gave citations for all her sources. Costs for her service are available on her website.

Mike cautioned anyone intending to use the service to send in the originals not photocopies of files to Briar Corson.

Early Auckland Research

I have just had a trip to Auckland and while there I visited the Auckland Public Library's Research Centre to do some research. It is good that one no longer has to pay to use the resources at the Centre. While there I discovered the books with the Registration forms for the Roll of Honour for the Pioneer Women's and Ellen Melville Memorial Hall.

"The information desired by the Record's committee of the above for the Roll of Honour of all Pioneer Women who were born, or who arrived, in the Auckland Province in or prior to the year 1875."

Sure enough, there was a form for my greatgreat grandmother Sutherland who came to Auckland with her Fencible husband in 1847. The information was submitted by her granddaughter. Of course, the information is only as good as the informant, but it still is very worthwhile to check out this material. Some pioneer women had a lot of information attached to their forms, others not so much.

What information is found on these forms?

- 1. Full name of pioneer woman
 - a) Maiden name
 - b) Married name and date of marriage
- 2. Date of arrival, name of ship
- 3. Where first settled in Auckland Province
- 4. a) Date and place of birth
 - b) Maiden and married name of mother
- 5. If still living, present age and address If deceased, date of and age at death
- 6. Items of interest re descendants and any outstanding incident or services rendered.
- 7. Name and address of person supplying this information.

The other area worth checking out is the Sir George Grey Collection situated on the same floor and just opposite the Research Centre. I was lead to go there after looking at the wonderful card index in the Research Centre. I had amazing help from the staff at the Grey Collection. I signed to have a look at two articles:

1. C. Little and Sons, Undertakers record books: I found details of my great-great grandmother's 1918 funeral. Very interesting. Particularly useful as I have found it difficult to find a

cemetery record for her.

I have just had a trip to Auckland and while there I visited the Auckland Public Library's Research Centre to do some research. It is good that one no longer has to pay to use the resources at the Soar.

In this small booklet I found birth and baptism records for some of my Sutherland Fencible family. More importantly, I found a record for my Irish great-great grandmother Sutherland saying where and when she was born in Ireland. I found this most interesting as the date conflicts with the age she was said to have died at -104! I have a strong belief that this St Peters church record is the right date.

I have found so many conflicting dates and data for this particular Fencible family. I guess that is just part of the fun and mystery of our genealogy hobby.


